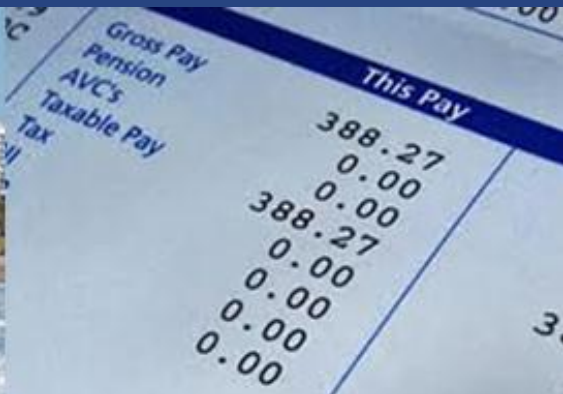
TRAINING AND DEVELOPMENT
